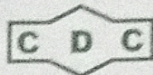

COMMUNIQUE

RE: SALE OF SUB – STANDARD (REJECT) BANANA FOR THE 2022 TO 2024 FINANCIAL YEARS

1. BACKGROUND

The Corporation is involved in the production of Banana in the Tiko plain, Fako Division, South West Region. The Bananas produced are sold under various brand names through our strategic partners in European Markets. The Tiko brand is sold in the Sub-Region. Bananas that do not meet the specifications of the brands referred to above commonly known as "Sub-Standard Banana", are sold locally.

As a result of the successful trial in recent years following calls for manifestation of interest in 2014 and 2016, CDC has decided to re-launch the sales of Substandardbananas for the period 2022 to 2024.

In order to maintain good quality and in conformity with the GLOBAL G.A.P standards for banana production, all Substandard Bananas must be evacuated within 24 hours from the packing stations. Hence, the prospective buyers are expected to own adequate and reliable logistics.

2. OBJECT

The General Manager of CDC invites prospective buyers to apply for the purchase of approximately 3,000 tons of Substandard Banana from the various Pack Houses in the Banana plantations in the Tiko plain .

3. ADMINISTRATIVE DOCUMENTS

These sales are open to prospective buyer's of banana (individual or banana buyer's Association/Syndicate) who shall provide the following documents:-

- a) Hand written application with fiscal stamp affixed.
- b) Provide a valid Tax Payer's card

- c) Have minimum experience with a major banana producer (PHP, BPL, CDC) of at least two (02) years in this domain (to be justified by collection notes and proof of payment).
- d) Show proof of logistics (10No trucks) to handle all the CDC Substandard Banana from her Packing Stations (to be justified by a Carte Grise in the name of the owner or certified Carte Grise ascertaining availability to the bidder).
- e) Any false declarations or documents shall lead to the out right elimination of the Buyer's offer.

4. TECHNICAL DOCUMENTS

The Technical documents shall comprise the following:

- One supported reference for similar services in Cameroon.
- Proof of availability of the necessary logistics to handle the evacuation of banana from packing stations.

5. EVALUATION

5.1 ELIMINATION CRITERIA

Documents shall be rejected when:

- There is absence of an Administrative Document
- Incomplete technical offer
- There are cases of forgery

The prospective buyer with the highest price offer shall be awarded the contract.

7. SUBMISSION OF OFFERS

Interested buyers shall submit their offers in four copies (one original and 3 copies) in a sealed envelope which shall be deposited in the General Manager's Office CDC Head Office – Bota (Room 301) on or before 14 AVR 2022 with the inscription;

8. BUYERS RETAINED

The list of the buyers retained shall be published via CDC Notice Boards and Radio/Newspapers.


NB:
